# Post-Acute Cardiac Management Speaker: Nicole Orr, MD, FACC

This session will provide an overview of treating complex geriatric cardiology patients in the skilled nursing setting and provide a practical approach to addressing clinical scenarios related to decompensated heart failure, assessment of multifactorial dyspnea, chest pain and rapid atrial fibrillation. Emphasis will be placed on strategies for and the importance of treating cardiac patients in the context of their multiple co-morbid illnesses.

- Discuss principles of patient-centered deprescribing related to cardiac conditions/symptoms in post-acute and long-term care
- Review framework for selecting medications appropriate for deprescribing
- Discuss practical strategies for deprescribing using care-based examples of patients in the skilled nursing setting

# Anticoagulation for Atrial Fibrillation in PALTC Speaker: Meenakshi Patel, MD, FACP, MMM, CMD

The session will discuss the appropriateness of anticoagulation treatment in the elderly population. We will discuss pros and cons of anticoagulation as well as true contraindications.

# Deprescribing Cardiovascular Medications in Older Adults: A Practical Approach Speaker: Nicole Orr, MD, FACC

This presentation will review a practical approach for deprescribing cardiovascular medications among frail older adults, within the context of optimizing physical function and addressing goals of care. As the leader of multiple successful post-acute cardiac programs, Dr. Orr offers vast practical experience for the SNF provider.

- Discuss the approach to management of patients presenting with acute heart failure
- Introduce practical strategies for assessing chest pain and indications for hospital transfer

**Nicole Orr, MD, FACC** is an Assistant Professor of Medicine in the Division of Cardiology at Tufts University School of Medicine, and the founder/president of Post-Acute Cardiology Care, LLC. Her work is dedicated to developing heart failure disease management programs in SNFs with a high burden of HF patients, with an emphasis on educating staff and residents about the complexity of treating this high-risk demographic. She serves both as a staff cardiologist and consultant, and provides weekly bedside rounds to several facilities in the Northeast region. She speaks nationally about the need to optimize strategies for treating geriatric cardiology patients admitted to post-acute care, and has published her work and

insights regarding best practices for post-acute HF management.



Meenakshi Patel, MD, FACP, MMM, CMD, is a Clinical Associate Professor at Wright State University in Dayton, Ohio. She is also a practicing physician at Valley Medical Primary Care as well as a Principal Investigator at Valley Medical Research, and Medical Director at several nursing homes. Dr. Patel earned her medical degree at the University of Bombay in Bombay, India. She completed a residency in Internal Medicine at Sinai Hospital in Baltimore, Maryland. She is

board-certified in Internal Medicine, Geriatrics, and Hospice and Palliative Care.



**Ronan Factora, MD** is Associate Professor of Medicine at the Cleveland Clinic Lerner College of Medicine at Case Western Reserve University and Program Director for the Geriatric Medicine Fellowship at the Cleveland Clinic. His areas of interest include Alzheimer's Disease and related dementias, falls, elder abuse, and preserving functional independence. His current areas of research are in the areas of cognitive screening and assessment of decision-making capacity. He is the current President of the Ohio Geriatrics Society. He has served as a member of the Ohio State Medical Board under Governor John Kasich and remains active on the

Attorney General's Elder Abuse Commission as the co-chair of the Research Subcommittee.



**Amanda Lathia, MD** is board certified in internal medicine and geriatric medicine. She is an assistant professor of medicine at Case Western Reserve School of Medicine and is a staff physician in the Division of Geriatrics and Palliative Care at University Hospitals in Cleveland, Ohio. She is the program director of the geriatric medicine fellowship and also the medical director of the Foley ElderHealth Center at University Hospitals. She has worked in post-acute and long-term care and has been a facility medical director. She is currently a member of the OMDA Board until October of 2022.

# Microbiome and Cardiovascular Health Speaker: Stanley Hazen, MD, PhD

In this presentation, we will show that the gut microbiome can be considered as a large endocrine organ– generating biologically active signaling molecules similar to hormones. The case will be made that gut health is a significant factor in aging and disease pathogenesis.

#### Session Learning Objectives

- Demonstrate a contributory role of intestinal microbes to development of atherosclerotic heart disease
- Understand how gut microbe-generated metabolite trimethylamine-N-oxide (TMAO), plays an active role in atherothrombotic and metabolic disorders
- Understand how gut microbe-generated metabolite phenylacetylglutamine (PAG), plays a role in cardiovascular disease risk in diabetics
- Recognize that gut microbiome is a potential therapeutic target for the prevention or treatment of cardiometabolic diseases



**Stanley Hazen, MD, PhD** received both clinical training in Internal Medicine and subspecialty training in Diabetes, Endocrinology and Metabolism from Barnes/Jewish Hospital, St. Louis, MO, and a PhD in Biophysical Chemistry and Molecular Biology from Washington University School of Medicine, St. Louis, MO. He holds multiple leadership positions at the Cleveland Clinic including chair of the Department of Cardiovascular & Metabolic Sciences, Lerner Research Institute, co-Section head of Preventive Cardiology & Rehabilitation, Heart, Vascular & Thoracic

Institute, and Director, Center for Microbiome & Human Health, Cleveland Clinic. Dr. Hazen is an elected fellow to both the National Academy of Medicine, USA, and the American Association for the Advancement of Science. He also is an elected member of the American Association of Physicians.

### Using the AMDA UTI Toolkit Speaker: David Nace, MD, MPH, CMD

Overdiagnosis of UTI in nursing homes continues to be a major problem. While surveillance criteria for UTI in long-term care residents are commonly referenced, a need exists for a practical approach to UTI management. The presenter led a federally funded antimicrobial stewardship project that developed simplified, evidence-based criteria for the diagnosis and treatment of UTI. Implementation of the criteria in a national cohort of nursing homes reduced treatment for asymptomatic bacteriuria and overall antibiotic use for UTI with no increase in hospitalizations or mortality. C difficile events were reduced in the treatment group. The session will present the evidence behind the toolkit and discuss strategies to implement the toolkit in your facility and practice.

- Describe the data supporting evidence-based treatment guidelines for UTI in post-acute and long-term care residents

# PDPM: What's New and Lessons Learned After 2 Years Speaker: Peter Van Runkle, OHCA

This session will provide an update on the Patient-Driven Payment Model (PDPM), the new Medicare reimbursement system for skilled nursing centers that began October 1, 2019. The presentation will examine what we have learned about PDPM, especially during the COVID-19 pandemic that has encompassed most of the new system's life. We will address potential changes to PDPM and related topics such as Value-Based Purchasing.

# Chronic Diarrhea – When it's not C difficile Speaker: Barbara Messinger-Rapport, MD, PhD, CMD

Chronic, frequent, and loose stooling in long-term care can lead to dehydration, skin breakdown, reluctance to mobilize, reduced socialization, weight loss, and falls. This session covers potentially reversible etiologies of chronic diarrhea (other than antibiotic related causes such as c difficile), including medication related diarrhea; severe constipation; microscopic colitis; and pancreatic insufficiency.

### Session Learning Objectives

- Consider vulnerabilities to diarrhea in older adults in the long-term services and supports arena
- List possible causes of and tests for non-infectious diarrhea in LTC
- Implement strategies to reduce chronic diarrhea in vulnerable elders



Barbara Messinger-Rapport, MD, FACP, CMD, HMDC is Medical Director of Vinney Palliative and Hospice Care of Menorah Park Senior Living, including 3 skilled nursing facilities, 3 assisted livings, 3 memory units, home care, dialysis, ambulance service, therapy, and other services. She completed a residency in Internal Medicine and a fellowship in Geriatrics. She is also certified in Hospice and Palliative Medicine, and holds CMD and HMDC certifications. She is Associate Professor of Medicine at Case Western Reserve University, is an affiliate with the VA Northeast Ohio, and works with the Ethics Program. IASSC Certified Lean Six

Sigma Black Belt. Special interests include quality of care at the end of life, safety, polypharmacy, and Goals of Care. When not working, she enjoys biking, cross-country skiing, and jogging.

# When CMS met SARS-CoV-2, it was an Expensive Introduction Speaker: William Vaughan, BSN, RN

This presentation will examine the state and federal regulatory response to the pandemic. Trends and patterns of deficiencies will be analyzed with a focus on emergency preparedness and QAPI. The outcome of several pandemic related cases which were litigated before an administrative law judge will be discussed. Finally, lessons learned regarding person-centered care during the pandemic, centering on informed consent, will be shared.

- Describe the trends and patterns of physician services and medical director deficiencies cited since the start of the pandemic
- Discuss the outcomes of enforcement actions taken by CMS and State survey agencies based on care provided during the pandemic
- · List the rights of residents under F552 regarding informed consent



**Bill Vaughan, RN** is a consultant, partnering with long term care providers to improve regulatory compliance, promote best practices and advance personcentered care. In his nearly 40 years as a registered nurse, Bill has held leadership positions including Chief Nurse at the Maryland State Survey Agency and Vice President of Education and Clinical Affairs at a LTC pharmacy providing services in over 30 states. He was a member of CMS expert panels that developed guidance to surveyors on pain and end of life care and recently worked as a CMS contractor on regulations related to QAPI. Over his career, he has given hundreds

of local, regional and national presentations on the regulation of health care facilities and has taught pharmacy and nursing students in multiple states. Bill is currently a faculty member for the ECHO/IHI National Nursing Home COVID Action Network and an advisor to the Institute for Safe Medication Practices LTC newsletter.

# Making Sense of Diets, Vitamins, and Supplements Speaker: Suzanne Cryst, RDN, CSG, LD

### Session Learning Objectives

- Identify nutrients to assess that may result in debility and need for supplementation
- Acknowledge nutrients in relationship to immune response, reducing inflammation and oxidative stress
- Identify why "food first" is not always enough or feasible

Over the years, discussions have evolved about the need and effectiveness of supplementation. During this session, several aspects of the change in life style and aging; understanding the difference of deficiency, insufficiency and sufficiency in relationship to immune response, inflammation and stress; and the changes in consuming, digesting and absorbing "food first" can be severely altered. The Nutrition Care Process and Physical Focus Physical Exam conducted by the Registered Dietitian in conjunction with Interdisciplinary Team will be discussed through the session.



**Suzanne Cryst, RDN, CSG, LD** is a registered licensed dietitian specializing in gerontological nutrition employed at Divine Rehab & Nursing at Canal Pointe Nursing in Akron. In addition to her advocacy for quality care, improved nutrition status and quality services for all ages, Suzanne is focused on the advancement of the dietetic profession by her commitment as a preceptor for numerous dietetic programs, and education of the intra- professional team at all levels. Suzanne had the distinct honor to co-author the Standards of Practice, Standards of Professional Performance for RDN's in Extended Care Settings that was published in 2018. She is currently the Chair of the Ohio AND Foundation and was appointed by the

Governor of Ohio to serve on the Malnutrition task force that submitted a paper on the issues surrounding Malnutrition in Ohio. Suzanne is Past Chair of the long-term care practice group – Dietetics in Health Care Facilities, Past President of the Ohio Academy of Nutrition and Dietetics, past Ohio Delegate Chair AND House of Delegates, and Past Ohio Public Policy Chair.

# PPI or Not: Collaborating with Your Consultant Pharmacist to Deprescribe Speaker: Alan Fox, RPh, BCGP

This presentation will discuss a brief history of Proton Pump Inhibitors and their possible over use in post-acute and long-term care. The art of deprescribing PPI's and other medications while utilizing your consultant pharmacist and building that relationship to reduce medication burden will also be explored. There will be a review of tools available in order to assist with reducing polypharmacy in your practice.

Management of Dysphagia in the Nursing Home

This course is intended to provide a multi-disciplinary focus on swallowing issues in the nursing home environment with a focus on identification of risk factors and potential causes, related diagnoses and diagnostic assessments (bedside, FEES vs MBS), and management within this setting from the perspective of both the SLP and the physician. Potential nutritional implications and other complications, with an emphasis on development of aspiration pneumonia, will be explored along with prognosis. Ethical issues with regard to diet levels, patient choice, and quality of life will also be addressed.

### Session Learning Objectives

- Describe the relationship between common conditions in LTC and dysphagia (including risk factors for dysphagia and prognosis)
- Compare the different types of objective testing of dysphagia
- List a range of possible recommendations based on dysphagia and nutritional considerations
- Incorporate ethics and patient/family preferences into decision making process regarding nutrition



**Zara Gennert, MACCCSLP**, has been a senior SLP at University Hospitals for over ten years, and works with patients of all ages and abilities, including dysphagia and dysphagia-related issues.

She is also an Associate Professor of Medicine at Case Western Reserve University. She has research funding from the VA, CDC and AHRQ and has published extensively in peer-review journals. She was a recipient of the 2021 AMDA Service Award for her work supporting efforts to fight the COVID-19 pandemic in long-term care settings.

Thomas Lehner, MD, CMD is the Medical Director for Long Term Care at the Buckeye Community Health Plan. He is board certified in Family Medicine, Hospice and Palliative Medicine and a Fellow of the American Academy of Family Practice. Dr. Lehner was certified as a Long-Term Care Medical Director (CMD) by AMDA – The Society for Post-Acute and Long-Term Care Medicine in 1998 and has been a member of the Society since 1996. He has served two terms on the Board of Directors of AMDA and continues to serve on a number of committees. Tom is the Immediate Past President of OMDA – The Ohio Society for Post-Acute and Long-Term Care Medicine and a member since 2005. He also serves as the Medical Director for Kindred Hospice, the Regional Medical Officer for Region 1 for the R3AP program in Ohio and a member of the Clinical Advisory Council for the Ohio Department of Aging. Dr. Lehner is the Medical Director for three Long-Term Care Facilities.



**John Weigand, MD** is a family physician and geriatrician who is the founding member of Central Ohio Geriatrics LLC and has served as Chief Medical Officer of National Church Residences, a non-profit organization that builds and maintains low-income senior housing in 25 states. He envisioned and implemented the Post-Acute Regional Rapid Testing (PARRT) Program at the onset of the COVID-19 pandemic which facilitated reliable testing in Ohio's nursing and assisted living facilities. He was named the Chief Medical Officer of the Regional Rapid Response Assistance Program (R3AP), a statewide COVID-19 support program for congregate-care settings through the Ohio Department of Aging. He was recently

named the LeadingAge Ohio 2020 Spotlight Award recipient for his work through the PARRT Program.



Randy Wexler, MD is Professor and Academic Vice Chair in the Department of Family and Community Medicine at the Ohio State University. Dr. Wexler received his undergraduate degree from Miami University in Oxford, Ohio. His Medical Degree is from the Wright State University School of Medicine in Dayton, Ohio, and his MPH is from the School of Public Health at the Ohio State University. # Evaluation of Weight Loss in the Nursing Home Speaker: Cynthia Kuttner, MD, CMD

Weight loss in nursing homes may be planned, undesirable, or unavoidable. Understanding how to define, evaluate, and treat patients with weight loss can help your quality measures. This lecture will define significant weight loss, propose a multidisciplinary evaluation process, and suggest treatment options.

#### Session Learning Objectives

- Define a significant weight change in post-acute/long-term-care, and what is a planned weight loss, an undesirable weight loss, and what may be an unavoidable weight loss
- Create a multidisciplinary plan to evaluate a significant weight change

# Responsible Opiate Prescribing in the Nursing Home Speaker: Monica Ott, MD, CMD

The session will discuss the prevalence of opioid prescribing and prevalence of persistent pain in nursing home residents. Three cases will be utilized to illustrate management of patients with acute pain and history of substance use, chronic pain and history of substance use, and red flags. The discussion will also include setting boundaries with patients and avoidance of compassion and allor-nothing traps.

#### Session Learning Objectives

- Identify patients at risk for opioid abuse in the nursing home setting
- Manage patients with acute pain and a history of substance use
- Evaluate patients with chronic pain and a history of substance use
- Set boundaries with patients to avoid compassion and all-or-nothing traps



**Monica Ott, MD, CMD**, is a geriatrician in Indianapolis, Indiana. She is the CCM (chronic care management) medical director for Optum in the Indiana market. Dr. Ott is a CMD (certified medical director). She has been involved with the Indiana chapter of AMDA for 10 years including as president, secretary, and treasurer.
