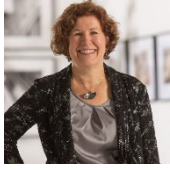

The other two are the Approaches project which seeks to implement an advance care planning program in 130 nursing homes and UPLIFT, which is clinical trial designed to establish a comprehensive palliative care program in sixteen nursing homes. Dr. Unroe serves on the editorial board of JAGS and has been the chair of the public policy committee of the AGS.

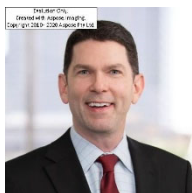
Negotiating Your Medical Director Contract

Speaker: Sean Fahey, JD

Medical Director Agreements are critical to establishing obligations and boundaries between the provider and the physician. There are a number of key provisions that Medical Director Agreements should have, including (a) the duties of the medical director; (b) compensation; (c) the licensure, criminal history, and exclusion status of the medical director; and (d) insurance and indemnity. Recently the Department of Justice has investigated False Claims Act violations arising from the alleged payment of kickbacks in the form of sham medical director agreements and payments to the spouses of referring physicians. This session will review the nuances of key agreement terms and address negotiation tips.

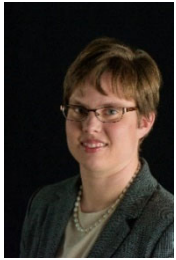

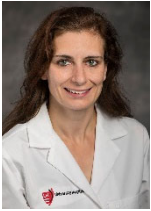
Geriatric research and quality improvement is being conducted in multiple settings throughout the State of Ohio. This session provides the opportunity for participants to present challenging patient cases and results of quality improvement and research projects. The design and implementation of research being conducted particularly in the long-term care environment will be reviewed. Cases from long term and post-acute care will also be presented and analyzed for opportunities for improvement in patient care. Discussion will provide the opportunity for input to those conducting studies to improve relevance to practice patterns. The goal of the session will be to present new ideas and delivery models and to identify patient care scenarios that impact patient outcomes.

Ronan Factora, MD is an Associate Professor of Medicine at the Cleveland Clinic Lerner College of Medicine at Case Western Reserve University and Program Director for the Geriatric Medicine Fellowship at the Cleveland Clinic Center for Geriatric Medicine. His areas of interest include Alzheimer’s Disease and related dementias, falls, elder abuse, and preserving functional independence. His current areas of research are in the areas of cognitive screening and assessment of decision-making capacity.

Speech Language Pathology and Long-Term Care: Aphasia and AAC

Speaker: Nancy Reinhardt, MACCC-SLP and Zara Gennert, ST

This presentation will help caregivers understand patients with communication challenges and how to better serve them. We will provide examples of communication strategies and alternative communication devices that may be helpful with communicating with this population. In addition, we will be reviewing different types of communication deficits that will likely be encountered in a long-term care setting along with examples. We will discuss ways to differentiate language, speech, and cognitive challenges and how to best communicate with these populations.

Zara Gennert, MACCC-SLP is a Senior Speech-Language Pathologist at University Hospitals Health System of Cleveland, Ohio. She has cared for patients in both acute care and outpatient settings for 15 years, including to help patients deal with aphasia and develop personalized AAC for them.

Diabetes Management in Long Term Care

Speaker: Naushira Pandya MD, CMD, FACP

This presentation will discuss the challenges in diabetes care in post-acute and long-term settings, the scope of hypoglycemia, individualized treatment goals and selection of therapeutic regimens, improvement of care transitions, and care of diabetes at the end-of-life. The role of the medical director and strategies for the facility and practitioner to improve care will be reviewed.

Naushira Pandya, MD, CMD, FACP is Professor and Chair of the Geriatrics Department at NSU, Kiran C. Patel College of Osteopathic Medicine, and the Project Director of the HRSA funded NSU South Florida Geriatrics Workforce Enhancement Program (GWEP). She is board-certified in Internal Medicine, Geriatrics, and Endocrinology and Metabolism, and is a certified medical director and a geriatrics fellowship program director. Dr. Pandya is Past President of AMDA, the national Society for Post-Acute and Long-Term Care Medicine and she has participated and led in the development of multiple clinical guidelines and position statements, and is a recognized for her work in the area of diabetes in the elderly. On a national level, she participated as a panelist in the White House Conference on Aging, and in the White House Conference on Antibiotic Stewardship, and served on Physician's Advisory Committee for the National Quality Forum, and as a member of College of Surgery Coalition for Quality in Geriatric Surgery. Dr. Pandya holds the distinction of being a Fulbright Senior Specialist Scholar.

Hyponatremia: Assessment and Management

Speaker: Eric Snyder, DNP, APRN-CNP

Hyponatremia represents a relative excess of water in relation to sodium. It can be induced by a marked increase in water intake (primary polydipsia) and/or by impaired water excretion due, for example, to advanced kidney failure or persistent release of antidiuretic hormone (ADH). This topic provides an overview of the assessment and treatment of adults with hyponatremia, including the pretreatment evaluation, selection of initial and subsequent therapy, goals of therapy, and common pitfalls.

- Define and describe the effects of hyponatremia on the brain and the resultant presenting signs and symptoms
- Discuss the approach to the patient with hyponatremia including the differential diagnosis and treatment
- Define and discuss the risks of rapid overcorrection or delayed therapy for hyponatremia



Eric Snyder, DNP, APRN-CNP is a board-certified acute care nurse practitioner who partners with Twin City Medical Center in Dennison, Ohio to provide hospitalist care to the community that is served by their critical access facility. After spending nearly 24 years in healthcare, from working as a nurse's aide to serving as medical staff president of the hospital, Eric has experienced the delivery of healthcare from many different perspectives. Apart from his local organizational involvement in APP practice changes, Eric also has been on the Board of Directors for the Ohio Association of Advanced Practices Nurses for 5 years and is Co-Director of the Government Relations Committee which involves him in state APRN practice legislative initiatives.
