1:00 – 2:30 pm Dementia Related Behavior Management Speakers: Daniel Heiser, PsyD, James Shackson, MD

The overall focus of this session is to identify the root causes of behaviors from a person-centered approach. This will include a discussion of the current models of dementia behaviors as well as the importance of proper clinical diagnosis. In addition, specific case examples will be presented to highlight the implementation of the clinical protocol. Understanding behavioral triggers and providing integrated clinical management can lead to improved care planning and positive outcomes, based on proper individual neuropsychiatric and/or psychiatric diagnoses, conceptualization and treatment.

2:30 – 3:30 pm Deprescribing CNS Medications – Case Studies and Panel

Speakers: Alan Fox, RPh, BCGP, Amita Patel, MD, CMD, MHA, CPE, Todd Sobol, MD, CMD

Many categories of medications affect the central nervous system (CNS) including but not limited to antidepressants, antiepileptics, antipsychotics, benzodiazepines, sedative/hypnotics, and opioids. The combination of multiple medications from these classes may incrementally contribute to adverse outcomes and morbidity. In the nursing home and assisted living settings, many patients experience cognitive decline, confusion, falls, etc. which can be attributed to CNS medications. Consultants, patients, and family members can be resistant to deprescribing due to an overestimation of the medication's efficacy, underestimation of the medication's potential side effects, and lack of insight related to the patient's wholistic state. This session will discuss how to evaluate indications, efficacy, and side effects for an individual patient who is prescribed multiple CNS medications. Talking points will be presented to assist providers in these conversations.

Screening for and Effective Treatment of Depression in the NH

Speaker: Amita Patel, MD, CMD, MHA, CPE

Depression is perhaps the most frequent cause of emotional suffering in later life. This significantly decreases quality of life in older adults. In recent years, the literature in late life depression has exploded. In this presentation, we will review how this affects our LTC and AL residents and the importance of screening tools for early recognition. We will also discuss the risk factors and diagnostic work-up. Finally, evidence will be presented for current therapies prescribed for depression. This includes risks and benefits of medications and psychotherapeutic and psychosocial interventions.

- Learn common screening tools used for depression in the LTC and AL setting
- Learn psychotherapeutic and psychopharmacologic treatments for depression

Current Concepts in Hip Fracture Management for NH Residents

Speaker: Steven Coss, MD, FAAOS

Hip fractures in the United States are estimated to be between 350,000 to 400,00 per year. In 2010 the annual economic burden of managing these fractures in the US alone was 17-20 billion dollars. Between 1986 and 2005 the annual mean number of hip fractures was 973/100,000 for women and 414/100,000 for men. The number of these types of fractures are anticipated to increase as baby boomers continue to age. Despite advances in treatment, morbidity and mortality (up to 25-30% first year) persists. Clinical guidelines continue to evolve and change regarding the post-operative care of these complex patients. This lecture and discussion will address current treatment guidelines and potential issues as integrated teams develop best practices to manage these patients.

Session Learning objectives:

- Understand the impact of current hip fracture care and projections of current and future economic impact given future population estimates
- Identify comorbidities and risks factors among this patient population that result in worse outcomes with a goal of early intervention to produce better outcomes
- As part of a multidisciplinary team, encourage input from all team members with the goal of the best outcome for these patients

1:30 – 3:00 pm Wound Care in the Nursing Home – Prevention and Treatment

Speakers: Louis Pilato, MD, Jamie Werts, APRN, CWS

It is essential for health care providers in the nursing home setting to understand how to prevent, treat and manage wounds. This presentation will provide up to date clinical and evidence-based findings regarding wound prevention, support surfaces, vascular wound assessments, edema and skin tears.

Session Learning Objectives

- Define the 3 components of pressure injury development
- Recognize the characteristics to consider when selecting a support surface
- Identify support surface groups and the intended use for each
- Describe accepted pressure redistribution positions and techniques for positioning
- Describe clinical findings associated with vascular wounds, skin tears, and edema
- Understand vascular testing and the methods used to access limbs with chronic wounds
- Discuss interventions related to the prevention of skin tears and treatment of edema



Louis Pilati, MD has been practicing in the Dayton area for over 23 years. Dr. Pilati received his education and residency training at Wright State School of Medicine and Kettering Medical Center. Dr. Pilati served as a senior Airman for the Medical Service Corps from 1982-1985 and received medals for Air Force Achievement and Good Conduct. 

Geriatric research and quality improvement is being conducted in multiple settings throughout the State of Ohio.
